Digital Copy of the 1437-1508 Court Book. This book along with others has come into the possession of the Lyme Regis Museum, having been returned from the Dorset Record Office in late 2016. The books are green cloth bound, measuring 13 by 8 inches (33 by 21 cm) and type written. Notations have been made in red ink to link passages to the reference section at the end, these are not included as they are repeated many times.

Page numbers are at the top right corner of each entry. Record numbers are included 1-19. It should be remembered when searching for any particular name / place that spellings can vary so reference to the surname variation spelling list in a separate file may help before entering name search text.

Note by the Transcriber

(Mr. J. R. Crompton of the Public Record Office, London)

In addition to the original documents, there is a book which contains an eighteenth century transcript of each of the documents. It is a transcript made word for word, preserving not only the original Latin but the original abbreviations and marginal notes. On the other hand, the present typed version is only an abstract, and in no sense an attempt to reproduce the original version literally. Legal verbiage, unnecessary repetitions, and marginalia when not of interest, have been left out, but the substance of every entry has been rendered into modern English which is the nearest possible equivalent to the meaning of the original. The original spelling of surnames and of place-names has been preserved.

No attempt at complete collation of the 18th century transcript with the originals has been made. It is on the whole quite a good transcript, but there are a number of inaccuracies here and there. I have not drawn attention to these. In a very few cases the documents have been so torn or dirtied since the 18th century that the transcript is the only authority left. I have noted these instances as they occur.

PREFACE

These are the earliest known Court Records of Lyme Regis - nineteen separate parchments in all extending (of course with many gaps) from August 26th, 1437 to October 2nd, 1508.

In all, during these 71 years. we have the proceedings of 50 Courts some of which are very short. This shows that much has been lost. In any case two meetings of the Court Leet were held each year, as well as one meeting for the election of the Mayor and other officials, which means that the proceedings of 213 Courts should have come down to us, apart altogether from what took place at the Weekly Mayor's Court.

It will thus be seen that the suggestion in the Preface to the Court Book of 1560-1564, viz., that none of the Court Records prior to 1560 had survived, is happily inaccurate. In fact, with the exception of the Court Book of Edward II (1307-27) most of the other parchments seem to have been discovered. Thus we have (in this volume) 17 Courts of Henry VI (1422-61), 5 of Edward IV (1461-83) and 28 of Henry VII (1485-1509) making up the total of 50 Courts. To complete those Courts set out in the Preface referred to above the one Court of Henry VIII may possibly be found at folio 13 of Fugitive Pieces II and the one Court of Edward VI at Folio II of Fugitive Pieces I. But it is impossible to speak with certainty on this point. Other fragmentary Courts of Henry VII (all referring to the business of the Mayor's Court) may be found at Folio 6 of Fugitive Pieces II.

Mr. Crompton is of opinion that all the parchments transcribed into this volume were written at the time and not compiled for any special purpose later.

It was the mysterious fact of the 18th Century transcript of the Latin version of these 19 documents which led to the search for and discovery of the originals, all of which may now be accounted for, except the Court Book of Edward II. That in all probability has not survived. In the case of one very faded original (No. 2) the 18th Century transcript has been invaluable. Other parchments as well are both faded and torn.

Readers should study the Indexes at end. Numbers in red in the text refer to the corresponding numbers in 'Glossary and notes'.

Andrew, Feast of St. (62, 80) Nov. 30th.

Apoundeforde (59). This "close" or locality of Lyme Regis cannot be identified.

Assize of Bread and/or Ale (4, 9, 15, 19, 25, 27, 28, 30, 36, 40) was held for settling their price in relation 1 to the current price of grain.

Assize of our lord the King (4, 54, 65). This may or may not refer to the Assize of Bread and Ale. Nothing can be said for certain on the point.

Bailiff(s) (1,etc, etc.) throughout this book seem to have been administrative officials of the Corporation. Serjeants (7 at Mace) first appear on p. 53.

Bartholomew, Feast of St. (1, 9, 15, 21, 32, 66, 72, 78,) April 24th.

Beaufront (48) occurs frequently as part of Lyme up to the early 17th century, but cannot be exactly identified. See note on p. 2 of the "Glossary and Notes" attached to "Fugitive Pieces" II.

Biconyll (39, 41), Sir John, as well as Sir Thomas Tremayle was a judge of the High Court. The two may have been on circuit, or acting as itinerant justices.

Blessed Virgin Mary. Tenement of, Bridge of, (45, 64, 74). It seems impossible to identify this with the Chapel on the Buddle Bridge, or with the Bridge itself, p. 45 shows that it was property owned by the Church.

bocher (26) butcher.

- Bonvile and Harington families (10, 23, 30, 33, 34, 38, 39, 42-44, 46, 49, 51, 55) were originally of Shute, Devon, and later on of Chewton, Somerset. They held land in Lyme (including the Manor of Colway) in the 15th century, and their device can be seen on one of the pillars of Lyme Church on the south side of the nave. Of those mentioned in the text:
- (1) Sir William Bonvile, Lord Chuton (Chewton), who married as his second wife, Elizabeth Courteney, widow of the 4th Baron Harrington, changed his politics by Joining the Yorkists Just before the second battle of St. Albans (Feb. 17th, 1461) and on the next day after the Lancastrian Victory was decapitated by order of Queen Margaret.
- (2) William, Lord Bonvile, grandson of Wm., Lord Harrington, was killed at the Battle of Wakefield, Dec. 31st, 1460.
- (3) Cecilia Bonvile, Lady Harrington, daughter of the above was a rich heiress, and married Thomas Grey, 1st Marquess of Dorset (1451-1501). She occurs in this book both as Cecilia, Marchioness of Dorset, (pp. 60. 65, 76) and as Lady Haryngton and Bonvyle (p. 76) and on the latter page she seems to have married, between 1501 and 1508, Lord Henry Stafford, Earl of Wiltshire.

Boy drowned in well (43). If the body was not recovered, hygiene would dictate the filling in of the well.

Bretone (23). It is impossible to say whether this is an ordinary name or intended for a native of Brittany.

Brooke family (7, 11, 23, 28, 33, 34, 38, 42-4, 46, 49, 51, 55, 60, 65, 75, 76), with the titles of Baron or Baroness Cobham succeeded the Bonviles later on as Lords of the Manor of Colway. Joan, Lady Brooke, was a Baroness in her own right.

burgage tenement (47, 48, 55, 61, 75) was held of the King or other lord for a certain yearly rent.

Burgh, John (30, 32, 33, 39, etc.) whose name, variously spelt, occurs so frequently (see Index of names) in this book was Mayor 1491/2, and represented Lyme Regis in the House of Commons twice, viz., in 1478, when his colleague was Sir Thomas Tremayle (see pp. 39 and 41), and again in 1491, when his colleague was John Tynham (Mayor 1451/2 and 1498/9), who is also frequently mentioned in this book. (See Index of names).

Butchers (59) This means of course that so single butcher is to be allowed to have two places in the shambles.

Capyshill (52, 53, 54, 77). This district, when the water trouble was so great, cannot be identified. It is similarly mentioned in Fugitive Pieces II, fo. 13, p. 6.

Chaplain (44, 55). This is more likely to be an office than a man's name. Possibly he was private Chaplain to some noble owner of land in Lyme.

Chapman (71). The proceedings of John Chapman, a "foreigner" seems to have been rather high-handed. He may have been acting for the town of Ottery St. Mary or for the J.P's or for itinerant justices, but he made submission to the Mayor of Lyme in the end.

Chuton, Lord (23, 55), see Bonvile family above.

Clement the Pope, Feast of (12). = Nov. 23rd.

Cobham, Lord (23, 28, 30, etc., etc.) see Brooke family above. Common Stream (27, 43, 80) i.e., of the town's supply of pot water.

Copps Lake (64) Cannot be identified. It seems to have taken its name from one John Coppe. It is referred to again in Fugitive Pieces 1, 45 (1496/7) and 52 (? 16-).

Cornishman (20). The meaning is probably that Robert Dare pays on behalf of a Cornishman who wishes to fish.

Corser (45) - horse dealer.

Cucking-stool (45) was in the form of a close-stool. The offender was fastened to it and exposed to the Jeers of the passers-by.

Customers (34) were the officials who collected the "customs" (see below).

Customs (7, 14, 19, 23, etc.) were port dues, and charges for fishing, selling wine and beer trading etc.. as indicated.

Dorset, Cecilia Marchioness of (See Bonvile).

Danyell, Stephen (58). This probably means that he was sworn before the Mayor as a Burgess. (See p. 45)

Essoin (2) i.e. the Defendant puts in some excuse non-attendance. Erlys (51) i.e., probably belonging to a man called Erie or Erly.

Fishing, penalty for (7, 17, 19). This may have had something to do with a boundary within which the right of fishing could only be enjoyed on payment of a tax.

Forener (19, 31, 61) i.e. one not a burgess of Lyme.

Frankpledge, View of (35, 39, 59, 62, 64, 70, 73, 76). The system whereby every member of a tithing was answerable for the good conduct of or for damage done by other members, and includes the power of holding a Court Leet.

Freeholders & suit of Court (4, 7, 11, 23, 28, 30, 33, 34, 41, etc.) This may have been a mere formality, so far as the smaller people were concerned. The bigger people would have been ready to pay, so as to avoid the trouble of coming to court.

Fullyforde

Fullyfords Will, i.e., well (37, 80). This place cannot be identified.

Gosselingbrigge (30, 40) is Gosling Bridge. [variously spelt]

Gretebrugge (40) Great Bridge and would seem to refer to the Buddie Bridge.

Groy, a ship of (29) seems inexplicable.

Hanger (35) is a short sword or cutlass.

Harbouring strangers or vagabonds (77) To conceal these, without reporting them to the authorities,

was an offence.

Hares and hounds (77) Except that Furser's status may not have qualified him for this sport,

his offence is not obvious.

Haryngton & Bonvile, Lady (76) In note on Bonvile above.

Helyers-brugge (33) This bridge cannot be identified.

Hocktide (7, 14, 35, 59) the second Monday and Tuesday after Easter. Hody, Sir William (38, 42-4, etc. - see Index of names) was Serjeant-at-Law and

Attorney-General 1485, Lord Chief Baron of the Exchequer 1486, died 1524. His home was at

Pillesdon. Earlier members of the family also had filled the highest judicial positions.

Holy Cross, Feast finding of (14, 19, 24) = May 3rd.

Horses astray (14, 69, 74). On p. 14 the stray horse is suspected to be Lydeford's and he is fined for not having it under control. On pp. 69 and 74 the stray horse is a "foreigner" and comes into the hands of William Dare, the Mayor. The horse remains in his custody for a year and a day and then, after due public notice given, becomes the property of the community.

Impleaded (51) prosecuted, brought an action against.

John the Baptist, Feast of the Nativity of $(26, 31, 32, 37, 61) = \text{June } 24^{\text{th}}$.

John before the Latin Gate, Feast of (18) = May 6th.

Lake (61, 74, 80) a dipping-place in the stream of the town's pot water.

Lawrence the Martyr, Feast of (33) = Aug. 10th. Luke the Evangelist, Feast of (10, 27) = Oct. 18th.

Lumbo de Lee (7) We have here probably the case of a "foreigner" fishing at Lyme

without permission or fee paid. The name is a curious one, but the clerk may have got it wrong.

Mainperned (6, 6) = became surety for.

Mainprise (60) i.e., Tyneham and Shelyngford had gone bail for Huett's appearance.

Martin the Bishop, Feast of $(74) = \text{Nov. } 11^{\text{th}}$. Mary Magdalene, Feast of $(60) = \text{July } 22^{\text{nd}}$.

Mary St., Bridge of (64) See "Blessed Virgin Mary" above.

Matthew, Feast of (45) = Sept. 21st.

Meryettesbrugge (32) This bridge cannot be identified.

Metes (37) = boundary marks.

May, Richard (37) His offence is not clear, he had no regular job and behaved suspiciously.

Michael, Feast of St. (3, 24, 36, 46) = Sept. 29th.

Mil hil (80) Is a corruption of 'Mulle Hulle' It is not a hill at all, but is explained by

Roberts (p. 44) as the low ground at the Mill. The Mill in question was one on the right bank of the river between the present steam laundry and Gosling Bridge.

Mylton Facomburgh (32) is Milton, a hamlet of Martock parish, Somerset, which was formerly called Milton Falconbridge.

Nativity of B.V.M., Feast of, (13, 69) = Sept. 8th.

Newenham Abbey (variously spelt 7, 11, etc., etc.) Some pieces of wall among the buildings of a farm-house on the E. side of the Axe about a mile below Axminster are all that remain of the once famous Abbey of Newenham founded in 1246.

Nicholas, Feast of $(6) = Dec. 6^{th}$.

Nytherlyme (19, 24). This and "Netherlym-supra-Mare" were former names for Lyme

Regis, whereby it was distinguished from Uplyme.

Obscure, to (61) = befoul.

"Oure Lady Hous" (58) See note 127 at Folio 101 of the portfolio III Fugitive pieces.

Paul, Feast of the Conversion (16) = Jan- 25th.

Pentecost, Feast of (43, 52, 53) i.e., Whitsunday. 7 weeks after Easter.

Penyme(a)de (1, 5) according to the Colway Tithing Boundary award at Folio 11 of

Portfolio IV, seems to have been a plot to the East of the Church between old Charmouth Lane

and the sea.

Peter ad Vincula, Feast of (7, 15) = Aug. 1st. Peter and Paul, Feast of (15) = June 29th.

Petty Customs (43, 46, 73) See "Customs" above.

Philip and James, Feast of (59) - May 1st.

Piepowder Court (29) It has generally been considered that the right of holding this Court was first given to Lyme by Mary Tudor in 1553. This mention of the Court at Lyme in 1472 is, another instance of rights exercised by the Borough for some years previous to the date when they were confirmed by charter or otherwise. The Court had to deal summarily and on the spot with disputes that arose over dealings in market.

Ponfold (46) = pinfold = pound.

Portrefes (62) are not necessarily connected with a sea port but are officers of a

borough under the Mayor.

Purification of B.V.M. Feast of (80) = Feb. 2nd.

puts himself, etc., (19) i.e., claims a trial by jury.

Rackclose (47, 60) is no doubt intended under these mis-spellings. It was here that the

Anning thunderstorm of 1800 killed three people. Receiver (21) i.e., of rents, fines, etc.

Reeve (2, 7, 9) is variously applied to the Chief Magistrate or any minor official of a

Borough.

Regrator (26, 61) is one who buys up commodities in a market to sell them again at a

profit, thus raising prices to his own advantage.

Relief (71, 75) is the fine paid on the renewal of a tenure or when it changed hands.

Sayme (17) or 'seam' fat, grease, lard.

Sawieisbrigge (45) This bridge cannot be identified.

Serjeants (? at Mace) (53) These are mentioned for the first time in this year (1501).

Sigger (59) one who steeps or soaks cloth in urine.

Simon and Jude, Feast of (5) = Oct. 28th.

Sklathe (44) possibly "skillet" a cooking utensil, saucepan, but a slate is written

sclathe, and sklaith.

Skynner, John (26) The meaning is that John Skynner, a stranger, came into Lyme and broke the King's peace.

Stakyng pens (1, 3. 6, 7. 9, 13, 14, 19, 21, 23-51, 27, 34, 62). This variously spelt and oft recurring word is literally the "pence" or fee payable for the privilege of putting up an ale-stake. (See 'Ale-Stake above).

Steward (39, 62, 67). One of the Bonviles was the Steward of Lyme's Court Leet in 1492, but had been replaced by a Wadham of Catherston

Tanner's (48) Cannot be identified.

Tapster (36, 40, 42, 63) was the keeper of a tavern.

Toll (20, 26, 36. 40, 42, 44, 46, 50, 52, 58, 62, 63, 65, 68,70, 76, 79). The excessive toll of millers was in charging more for their flour than the price fixed at the Assize of Bread and Ale.

Tremayle (39, 41) Sir Thomas Tremayle, a Judge of the High Court, was a Somerset man who represented Lyme in the House of Commons in 1478. See "Biconyll" above.

Tynham, John (11, etc.) see 'Burgh.' above and Index of Names.

Vatilda (28) probably - Matilda.

Vicar of Lyme (13, 14) William Bynham (1442) is not included in the list of Vicars given by Roberts (p. 104). his list has a gap between 1425 and 1534.

Vigil - the eve preceding a festival.

Virgin Mary, Feast of the Purification (29) = Feb. 2nd

Wabrondismede (45) cannot be identified. Wadham, William (30, 33, 40, 67) of Catherston.

Washing in town pot water (40, 47, 54, 61. 65, 80). The offence of washing one's dirty linen in the stream of the town's pot water (pp. 47, 50) is brought up once more later on in Fugitive Pieces II, fo. 79, p. 1 of 1609. The washing of linen or woollen cloth in process of manufacture, as referred to on the other pages, must have fouled the water supply still more.

Wathe (12, 47) cannot be identified. It is referred to in Fugitive Pieces II, fo. 7, pp. 4, 6, and fo. 16, p. 6.

Westfield (12) cannot be identified.

West Street (31, 60). The occurrence of this former name of Broad Street so early as 1478

is interesting.

Withe, the, (46) cannot be identified.

Writs (34) suitors would pay 3d. for each writ issued by the Court to compel a defendant to appear.

Wyght (33) This man may possibly have come from the Isle of Wight.

Wymarke (8, 10) This curious name of the wife of Walter Tanner was not unknown at this time (1440) and may be of Dutch origin.
